#### **New Business**

#### **Lift Station Pumps**

Currently both pumps are working. Pump 1 is in poor condition. Pump 2 was bought new in 2008, is also in poor condition. Pump 2 is about to burn out but can be repaired. AquaTrol is monitoring lift station on an every other day basis. AquaTrol may begin to charge additional fee for extra visits. Board is waiting on estimate from an additional company to resolve lift station issue in a different manor with a more current/capable pump style. Company will be provided with a key to gain entrance to lift station in order to see issue for themselves. Board will check Angie's List and BBB for information regarding this company. Board will look into maintenance contract for emergency generator in the lift station.

### **Rotten Wood/Pressure Washing/Painting**

Board will determine if rotten wood is an issue with all units or only some. This issue will be reviewed in the future.

Board will finish up estimates to pressure wash only those units that have visible mildew on them.

Painting has been put on hold until rotten wood and pressure washing have been dealt with.

#### **Detention Pond**

Board will look into getting Rip Rap to place in each Detention pond to help with drainage. Currently, the ponds have standing water in them. They each should drain empty.

#### **Parking**

Board reviewed how current parking restrictions are enforced in the community. Board decided to hold parking forums to allow homeowners to voice their opinions on the current parking restrictions. Board will wait until the forums are completed before making a decision regarding the parking.
